- 3. Treasurers Report Jeanne
  - a. \$8037 in bank, see attached financial report

The quarterly LMSC meeting falls the last week of September, so the financial report is through the end of August and does not include delegate expenses for Donn and Jeanne to attend the USMS annual meeting in Denver, Sep 16-18. We budgeted \$1,000 each for 2 people. USMS charges the LMSC \$250 per delegate to cover meals and lodging (1/2 double occupancy room). The LMSC reimbursed airfare, airport parking, mileage to and from home airport, travel lunch to and from. Total LMSC expenses were \$1,606.83. This will show up on the financial statement for our 4th quarter meeting in December.

  - Membership Coordinator Marcie Bachman
    - o 190 members in LMSC. This is an increase from last year.
    - o 2021 161 members.
  - Top-10/Records Josh Huckeby

    - End of year for Top 10 long-course should be included at the end of the month of September.

    - USMS has it on the docket to redo the sanction application software, which will make it an easier process.
    - o We need a new member to take on this role.
      - Club reps please get the word out.
      - On the job training.
      - Need someone who is good at outreach to the USA Swimming meet host.
  - Coaches Paul Landes
    - Not much activity since June meeting.

- Webmaster Mackenzie Jones
  - o Updates will be made to the website soon.
  - We need a new member to take on this role.
    - Club reps please get the word out.
    - On the job training.
- Clubs Peggy (BSMT)
  - o Great summer!
  - Kalispell club, Mark Johnson, Swam at Flathead Lake at Poker paddle, Long Bridge Swim with Big Sky members.
  - o OWS Clinic was completed in Helena.
  - Adult Learn to Swim was a success, we got in the Helena IR. We added a few members from that program.
  - o More people are joining regularly.
- Brady (MMMT)
  - o Masters started back up at the YMCA, practice Mon and Weds.
  - More people are coming out because we changed the time to 6-8 pm. We have people swimming with us that are at all abilities.
  - o The GRIZ pool has limited lifeguards so limited hours right now.
  - o Some swimmers did open water swims over the summer.
  - o Some longer swims are planned for this coming summer.
  - o 5 members who were registered in 2021.
  - o 17 people are coming to practice, let's get them registered.
- Suzette (BOZE)
  - o Bozeman doesn't have an indoor pool right now.
  - They hope to open the Swim Center indoor pool (50 m) in later October.
  - There is only an outdoor pool and it is getting too cold.
  - There is no lobbying opportunity through the club, but the kids Barracuda club goes to the City Commissioner meetings every time.
  - Donn offered to provide support by attending meetings or writing a letter to the City Commissioner.
- 6. Old Business Information & discussion
  - LMSC's board member transition procedure- Mackenzie
    - o Mackenzie will create a template.
      - Clear roles and responsibilities tailored to Montana for the 4 elected officers, representatives from the 5 largest clubs (3 clubs), and Exo-officio positions (appointed positions).
      - The bylaws don't include these descriptions because the USMS website.
      - Then each board member can make edits to tailor the description.
      - It will also include time commitment and training needs.

- This document should include clear expectations, time commitment, new member training plan, and end of term cessation plan.
- This is necessary for the appointed positions, especially.
- 7. New Business Information, Discussion, Action
  - Level I & II Coaches and ALTS training Oct. 29 & 30 in Hood River, OR
  - Level II Coaches training, San Jose, CA Dec.3 Suzette and Kris
    - o Registration for Level 1 \$150/person
    - o Registration for Level 2 \$125/person.
    - o Room approx. \$180 x 2 nights (shared room) = \$180/person.
    - o Flight \$350/person.
    - Total expenses for attaining Level I and II Coaches training = \$750/person.
    - Past practice of reimbursing registration fees = Scholarship of \$275 in addition to registration.
    - MSA to reimburse Suzette and Kris up to \$400 expenses incurred for getting Level 1 and 2 certifications in San Jose, CA in December.
  - Annual Meeting Report Donn & Jeanne
    - 235 delegates attended in total, about 180 delegates attended in person in Denver at the Westin Hotel. Friday – Sunday. Excellent conversation, networking, and program.
    - The national office prepares the budget for USMS and made a 3 year projection. They project that by 2025 there will be a dues increase and a membership increase that will help us breakeven.
      - 60.000 members for 2023
      - 65,000 members for 2025
      - \$10 increase for registration with a \$5 discount for those that register before December 31, 2022.
      - Fee is up for clubs and workout groups \$65 until November 1<sup>st</sup>, and then goes up to \$70.
        - Peggy is proposing to the Big Sky club that they pay their workout group registration fee.
      - LMSC will continue to get 20% \$13-14 respectively.
    - Approved \$20 One Event Fee for a non member to participate in sanctioned events. The fee has been proposed to remain the same for 2023 and 2024.
  - 2023 LMSC Member Rebate
    - Rebate for all members from the LMSC
    - o MSA to offer the rebate program again
    - LMSC hopes to get a jump start on this again this year.
  - 2023 LMSC Budget Requests by Nov. 30.

  - 2023 State Meet & Annual Meeting
    - We need a meet director, officials, and date
